STIPULATION

a Justice of the Rossie Town Court,
St. Lawrence County.

IT IS HEREBY STIPULATED AND AGREED by and between Robert H. Tembeckjian, Administrator and Counsel to the Commission, and the Honorable Linda J. Drake ("Respondent") and her attorney, Henry J. Leader, Esq.:

1. Respondent has been a Justice of the Rossie Town Court, St. Lawrence County, since 1998. Her current term expires December 31, 2017. She is not an attorney.
2. Respondent was served with a Formal Written Complaint dated February 16, 2017 containing four charges. The Formal Written Complaint is appended as Exhibit 1.
3. Respondent enters into this Stipulation in lieu of filing an Answer to the Formal Written Complaint.
4. Respondent tendered her resignation dated May 5, 2017, a copy of which is appended as Exhibit 2. Respondent affirms that she will vacate judicial office on May 19, 2017.
5. Pursuant to Section 47 of the Judiciary Law, the Commission has 120 days from the date of a judge's resignation to complete proceedings, and if the Commission

determines that the judge should be removed from office, file a determination with the Court of Appeals.

6. Respondent affirms that, having vacated her judicial office, she will neither seek nor accept judicial office at any time in the future.

7. Respondent understands that, should she abrogate the terms of this Stipulation and hold any judicial position at any time in the future, the present proceedings before the Commission will be revived and the matter will proceed to a hearing before a referee.

8. Upon execution of this Stipulation by the signatories below, this Stipulation will be presented to the Commission with the joint recommendation that this matter be concluded, by the terms of this Stipulation, without further proceedings.


9. Respondent waives confidentiality as provided by Section 45 of the Judiciary Law, to the extent that (A) this Stipulation will become public upon being signed by the signatories below, and (B) the Commission's Decision and Order regarding this Stipulation will become public.



**FORMAL
WRITTEN COMPLAINT**

LINDA J. DRAKE,

a Justice of the Rossie Town Court,
St. Lawrence County.

1. Article 6, Section 22, of the Constitution of the State of New York establishes a Commission on Judicial Conduct (“Commission”), and Section 44, subdivision 4, of the Judiciary Law empowers the Commission to direct that a Formal Written Complaint be drawn and served upon a judge.

2. The Commission has directed that a Formal Written Complaint be drawn and served upon Linda J. Drake (“Respondent”), a Justice of the Rossie Town Court, St. Lawrence County.

3. The factual allegations set forth in Charges I through IV state acts of judicial misconduct by Respondent in violation of the Rules of the Chief Administrator of the Courts Governing Judicial Conduct (“Rules”).

4. Respondent has been a Justice of the Rossie Town Court, St. Lawrence County, since 1998. Her current term expires on December 31, 2017. Respondent is not an attorney. The Rossie Town Court does not have a clerk.

CHARGE I

5. From on or about March 23, 2012, through in or about August 2016, as set forth on the annexed Schedule A, Respondent failed to deposit court funds into her court bank account in the manner required by Section 214.9(a) of the Uniform Civil Rules for the Justice Courts, in that she made 31 deposits into her court bank account in which the amount deposited was less than the amount received by her court since the previous deposit, and 10 deposits in which the amount deposited was more than the amount received by her court since the previous deposit, resulting in a cumulative deficiency of deposits to the court's bank account totaling \$3,047.50.

6. By reason of the foregoing, Respondent should be disciplined for cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that Respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that she failed to respect and comply with the law and failed to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules; and failed to perform the duties of judicial office impartially and diligently, in that she failed to be faithful to the law and maintain professional competence in it, in violation of Section 100.3(B)(1) of the Rules, and failed to diligently discharge her administrative responsibilities and maintain professional competence in judicial administration, in violation of Section 100.3(C)(1) of the Rules.

CHARGE II

7. On or about April 11, 2014, Respondent deposited \$448 in court funds into the court's bank account and received a \$100 cash withdrawal from those funds, in violation of Section 27(1) of the Town Law and Sections 2020 and 2021 of the Uniform Justice Court Act. On or about May 2, 2014, Respondent submitted her monthly report to the Office of the State Comptroller Justice Court Fund and failed to report or remit the \$100 in court funds that she had withdrawn on April 11, 2014, in violation of Section 27(1) of the Town Law.

Specifications to Charge II

8. On or about April 11, 2014, Respondent received a teller check from defendant Douglas S. Peck in the amount of \$93. A copy of the teller check is included in Exhibit 1, appended hereto. On the same date, Respondent issued Mr. Peck a receipt for \$93. A copy of the receipt is annexed as Exhibit 2.

9. On or about April 11, 2014, Respondent received a money order from defendant Korey Ayers in the amount of \$355. A copy of the money order is included in Exhibit 1. On the same date, Respondent issued Mr. Ayers a receipt for \$355. A copy of the receipt is annexed as Exhibit 3.

10. On or about April 11, 2014, Respondent deposited \$448 into the court account at Community Bank, N.A. in Gouverneur, NY, representing the monies she had received from Messrs. Peck and Ayers. Respondent requested and received a \$100 cash withdrawal from the deposit. A copy of the deposit slip is included in Exhibit 1.

11. On or about May 2, 2014, Respondent submitted to the Office of the State Comptroller Justice Court Fund her monthly report for April 2014. Respondent reported to the Comptroller that she collected \$93 from Mr. Peck. Respondent falsely and/or inaccurately reported to the Comptroller that she collected only \$255 from Mr. Ayers. A copy of Respondent's April 2014 monthly report is annexed as Exhibit 4.

12. By reason of the foregoing, Respondent should be disciplined for cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that Respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that she failed to respect and comply with the law and failed to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules; and failed to perform the duties of judicial office impartially and diligently, in that she failed to be faithful to the law and maintain professional competence in it, in violation of Section 100.3(B)(1) of the Rules, and failed to diligently discharge her administrative responsibilities and maintain professional competence in judicial administration, in violation of Section 100.3(C)(1) of the Rules.

CHARGE III

13. From in or about May 2012 through on or about September 1, 2016, Respondent failed to report to the Justice Court Fund of the State Comptroller, by the 10th day of the month succeeding collection, the receipt of court funds totaling \$8,632 and

failed to remit those funds to the Town of Rossie, as required by Section 1803 of the Vehicle and Traffic Law, Sections 2020 and 2021 of the Uniform Justice Court Act, Section 27(1) of the Town Law and Section 99-a of the State Finance Law.

Specifications to Charge III

14. From in or about April 2012 through on or about June 1, 2016, as set forth on the annexed Schedule B, Respondent received a total of \$8,172 in court funds in approximately 43 matters which, as of September 1, 2016, she failed to report to the Justice Court Fund of the State Comptroller and failed to remit to the Town of Rossie.

15. Beginning in or about June 2012 through on or about January 20, 2016, as set forth on the annexed Schedule B, Respondent collected \$1,531 with respect to eight matters, but falsely and/or inaccurately certified in her monthly reports to the State Comptroller that she received only \$1,071 in those cases. Respondent failed to remit the difference of \$460 to the Town of Rossie.

16. By reason of the foregoing, Respondent should be disciplined for cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that Respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that she failed to respect and comply with the law and failed to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules; and failed to perform the duties of judicial office impartially and

diligently, in that she failed to be faithful to the law and maintain professional competence in it, in violation of Section 100.3(B)(1) of the Rules, and failed to diligently discharge her administrative responsibilities and maintain professional competence in judicial administration, in violation of Section 100.3(C)(1) of the Rules.

CHARGE IV

17. From in or about January 2012 to in or about August 2016, as set forth on the annexed Schedule C, Respondent failed to report the dispositions of 615 cases to the Department of Motor Vehicles as required by Section 514(1) of the Vehicle and Traffic Law and Sections 91.12 and 91.19 of the Regulations of the Commissioner of Motor Vehicles.

18. By reason of the foregoing, Respondent should be disciplined for cause, pursuant to Article 6, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that Respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that she failed to respect and comply with the law and failed to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules; and failed to perform the duties of judicial office impartially and diligently, in that she failed to be faithful to the law and maintain professional competence in it, in violation of Section 100.3(B)(1) of the Rules, and failed to diligently

discharge her administrative responsibilities and maintain professional competence in judicial administration, in violation of Section 100.3(C)(1) of the Rules.

WHEREFORE, by reason of the foregoing, the Commission should take whatever further action it deems appropriate in accordance with its powers under the Constitution and the Judiciary Law of the State of New York.

Not realizing the computer wasn't set up properly, I had not sent any dispositions. I believe I have now taken care of this. Also, I did not have internet service at the Court.


