Washington County Town Justice Censured for Misconduct Compromising His Impartiality in Several Cases

The New York State Commission on Judicial Conduct has determined that Michael M. Feeder, a Justice of the Hudson Falls Village Court, Washington County, should be censured.

In a determination dated November 18, 2009, the Commission found that Judge Feeder should be sanctioned for engaging in numerous acts of misconduct. In one instance, the judge confronted a motorist and identified himself as a judge, used his judicial power to cause the arrest of the motorist and commented publicly about the case while it was pending.

The judge also had an out-of-court conversation with a defendant's mother who asked him not to sentence the defendant to jail, then sentenced the defendant according to the request; granted an adjournment in contemplation of dismissal in a case without the required consent of the prosecution; and presided over cases

filed by members of the Hudson Falls Police Department without disclosing his close friendship with the Assistant Chief of Police, who in at least one case appeared before the judge personally.

"This series of misdeeds, which are essentially undisputed, shows insensitivity to the high ethical standards required of judges and warrants a severe sanction," the Commission said in its determination.

The Administrator of the Commission had recommended that Judge Feeder be removed from office. Three Commission members voted for the judge's removal.

The Commission Proceedings

Judge Feeder was served with a Formal Written Complaint dated April 19, 2006, containing four charges, and a second Formal Written Complaint dated October 9, 2007, containing one charge.

On January 29, 2008, the Commission granted a summary determination based on the judge's failure to answer the charges. By stipulation, the parties agreed to vacate the summary determination. A hearing was held before a referee, Michael J. Hutter, Esq., on August 18 and 19, 2008, in Albany. Mr. Hutter filed a report with proposed findings of fact and conclusions of law dated June 29, 2009.

The parties submitted briefs with respect to the referee's report and the issue of sanctions. The Commission heard oral argument on September 23, 2009.

The Commission Determination

The Commission filed a determination dated November 18, 2009.

Six members concurred as to the sanction of censure: Stephen R. Coffey, Esq. (the Vice Chair), Paul B. Harding, Esq., Elizabeth B. Hubbard, Judge Jill Konviser, Judge Karen K. Peters and Judge Terry Jane Ruderman.

Three members – Judge Thomas A. Klonick (the Commission Chair), Richard D. Emery, Esq. and Nina M. Moore – dissented as to the sanction and voted for the judge's removal. Mr. Emery wrote a dissenting opinion which Judge Klonick and Ms. Moore joined.

Three members – Mr. Coffey, Ms. Hubbard and Judge Konviser – voted to dismiss

the charge involving Judge Feeder's disposition of a case without the prosecutor's consent.

One member, Joseph W. Belluck, Esq., was not present.

Court of Appeals Review

The Commission transmitted its determination to the Chief Judge of the Court of Appeals, pursuant to Judiciary Law Section 44, subdivision 7.

A judge may either accept the Commission's determination or, within 30 days of receipt, make a written request to the Chief Judge for a review of the determination by the Court of Appeals.

Pursuant to Judiciary Law Section 44, subdivision 7, if Judge Feeder does not request review by the Court of Appeals, the Commission will censure him in accordance with the determination.

If the Commission's determination is reviewed by the Court of Appeals, the Court may accept the determined sanction, impose a different sanction including admonition, censure or removal, or impose no sanction.

Statistics Relating to Prior Determinations

Since 1978, the Commission has censured 278 judges in New York State, 196 of who were part-time judges. The Commission has issued a determination of removal as to 160 judges and has admonished 235 judges.

The Court of Appeals has reviewed 90 Commission determinations. The Court accepted the Commission's sanctions in 75 cases (66 of which were removals, 6 were censures and 3 were admonitions). Of the remaining 15 cases, two sanctions were increased from censure to removal, and 13 were reduced: 9 removal determinations were modified to censure, one removal was modified to admonition, two censures were modified to admonition, and one censure was rejected and the charges dismissed.

Senior Investigator David Herr assisted in the investigation.
