

AFFIRMATION IN SUPPORT OF MOTION FOR SUMMARY <u>DETERMINATION</u>

#### DAVID W. WILBANKS,

a Justice of the Fort Covington Town Court, Franklin County.

**CATHLEEN S. CENCI**, an attorney duly authorized to practice in the courts of the State of New York, affirms under the penalties of perjury:

1. I am a Deputy Administrator for the New York State Commission on

Judicial Conduct ("Commission"). I submit this affirmation in support of a motion for summary determination in the above-captioned matter.

2. Pursuant to Section 44, subdivision 4, of the Judiciary Law of the State of New York, the Commission directed that a Formal Written Complaint ("Complaint") be served upon the Honorable David W. Wilbanks ("Respondent"),

a Justice of the Fort Covington Town Court, Franklin County.

3. The Complaint, dated October 26, 2023, contains two charges alleging that Respondent: (1) failed to timely report or remit court funds to the Office of State Comptroller; and (2) failed to cooperate with the Commission's investigation into that allegation. A copy of the Complaint and exhibits is annexed as <u>Exhibit A</u>. 4. On November 11, 2023, Respondent was personally served with a Notice of Formal Written Complaint and the Complaint. A copy of the affidavit of personal service is annexed as <u>Exhibit B</u>.

5. Pursuant to Section 7000.6(b) of the Commission's Operating Procedures and Rules, Respondent's verified Answer was due within 20 days of service of the Complaint. Respondent has not served an Answer to the Complaint to date and the 20-day deadline for him to do so has expired.

6. Pursuant to Section 7000.6(b) of the Commission's Operating Procedures and Rules, because Respondent failed to answer to the Complaint, all the allegations in the Complaint are deemed admitted by Respondent. Based on Respondent's failure to serve an Answer, there is no genuine issue as to any material fact, and summary determination is appropriate, pursuant to the Section 7000(6)(c) of the Commission's Operating Procedures and Rules.

7. As set forth more fully in the accompanying Memorandum by Commission Counsel, Respondent's misconduct as set forth in the Complaint is hereby established. Accordingly, Commission Counsel respectfully requests that the Commission grant summary determination as to Charges I and II of the Complaint.

WHEREFORE, it is respectfully submitted that no issues of fact exist, and that summary determination be entered finding that Charges I and II of the Complainant are sustained, that Respondent has engaged in judicial misconduct, and that a date be set for memoranda to be filed and oral argument to be heard on the issue of sanction.

1. Article VI, Section 22, of the Constitution of the State of New York establishes a Commission on Judicial Conduct ("Commission"), and Section 44, subdivision 4, of the Judiciary Law empowers the Commission to direct that a Formal Written Complaint be drawn and served upon a judge.

2. The Commission has directed that a Formal Written Complaint be drawn and served upon David W. Wilbanks ("Respondent"), a Justice of the Fort Covington Town Court, Franklin County.

3. The factual allegations set forth in Charges I and II state acts of judicial misconduct by Respondent in violation of the Rules of the Chief Administrator of the Courts Governing Judicial Conduct ("Rules").

Respondent has been a Justice of the Fort Covington Town Court,
 Franklin County, since January 1, 2021. His term expires on December 31, 2024.
 Respondent is not an attorney.

#### **CHARGE I**

5. For the months of December 2022 through May 2023, Respondent failed to report and remit court funds in a timely manner to the Office of the State Comptroller ("Comptroller"), as required by Section 1803 of the Vehicle and Traffic Law, Sections 2020 and 2021 of the Uniform Justice Court Act, Section 27, subdivision 1 of the Town Law and Section 99-a of the State Finance Law.

#### **Specifications to Charge I**

6. On or about February 14, 2023, the Comptroller issued to Respondent a written notice that his December 2022 monthly report had not been filed by the 10<sup>th</sup> day of the following month as required and still was not on file with the Comptroller. A copy of the notice is annexed as <u>Exhibit 1</u>.

7. On or about March 22, 2023, the Comptroller issued to Respondent a second written notice that his December 2022 monthly report had not been filed, and simultaneously notified him that he had failed to file his January 2023 monthly report by the 10<sup>th</sup> day of the following month as required. A copy of the second notice is annexed as <u>Exhibit 2</u>.

8. Respondent failed to file his February 2023 monthly report by the 10<sup>th</sup> day of the following month as required, and it remained unfiled through on or about mid-April 2023.

9. On or about April 20, 2023, the Comptroller left a phone message for Respondent regarding his still-unfiled reports for December 2022, January 2023, and February 2023, as a courtesy before mailing him a notice that his salary would be stopped in connection with those delinquencies. A copy of the Justice Court Fund (JCF) phone record is annexed as <u>Exhibit 3</u>.

10. That same day, the Comptroller also sent an email to Respondent, again noting the delinquent December 2022 and January 2023 monthly reports and notifying him of his failure to file his February 2023 monthly report in a timely manner. A copy of the April 20, 2023, email is annexed as <u>Exhibit 4</u>. The email further advised Respondent of the prior written notices, as well as the phone message left for him that same day, concerning his delinquent reports.

On or about April 18, 2023, the Comptroller notified the Fort
 Covington Town Supervisor to stop Respondent's judicial salary in connection
 with his failure to file his monthly reports for December 2022, January 2023 and
 February 2023. A copy of the stop-salary notice is annexed as <u>Exhibit 5</u>.
 Thereafter, Respondent failed to timely file his reports for March, April and May 2023.

12. Respondent failed to file his monthly reports with the Comptroller for the months of December 2022 through May 2023 until on or about July 6, 2023.

Thereafter, Respondent's judicial salary was resumed. A copy of the resumesalary notice, dated July 17, 2023, is annexed as <u>Exhibit 6</u>.

13. By reason of the foregoing, Respondent should be disciplined for cause, pursuant to Article VI, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that Respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violation of Section 100.1 of the Rules; failed to avoid impropriety and the appearance of impropriety, in that he failed to respect and comply with the law and failed to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules; failed to perform the duties of judicial office impartially and diligently, in that he failed to insure that his judicial duties take precedence over all his other activities, in violation of Section 100.3(A) of the Rules, failed to be faithful to the law and maintain professional competence in it, in violation of Section 100.3(B)(1) of the Rules, and failed to diligently discharge his administrative responsibilities and maintain professional competence in judicial administration, in violation of Section 100.3(C)(1) of the Rules.

#### **CHARGE II**

14. From in or about May 2023 to in or about August 2023, Respondent failed to cooperate with the Commission's investigation of the complaint that he failed to timely report and remit court funds to the Comptroller, in that he:

- A. failed to respond to two letters from the Commission requesting his response to the complaint concerning his failure to report and remit to the Comptroller;
- B. failed to produce court records and other related documents requested by the Commission; and
- C. failed to appear for scheduled testimony before the Commission, as was required.

#### **Specifications to Charge II**

15. Section 44, subdivision 3, of the Judiciary Law, and Volume 22, Sections 7000.3(c) and (e) of the New York Codes, Rules and Regulations (22 NYCRR 7000.3[c] and [e]), authorize the Commission to request a written response from a judge who is the subject of a complaint, and to require a judge's testimony during an investigation.

16. By letter dated May 3, 2023, the Commission notified Respondent that it was investigating a complaint from the Comptroller alleging that he had failed to file reports or remit funds to the Comptroller in the time required by law for the months of December 2022, January 2023, and February 2023, which resulted in his judicial salary being stopped on or about April 18, 2023. The letter requested that Respondent provide a written response to the allegations and to produce court records and other related documents by May 31, 2023. The letter was sent to Respondent by regular mail and via email to his court system account:

@nycourts.gov. A copy of the letter is annexed as Exhibit 7.

17. Respondent failed to respond to the Commission's letter of May 3,2023, and failed to produce any documents requested therein.

18. By letter dated June 14, 2023, the Commission sent Respondent a copy of its letter dated May 3, 2023, and requested his response by June 28, 2023. The letter informed Respondent that his "<u>failure to respond may be found by the Commission to be failure to cooperate with the investigation</u>" (emphasis in original). A copy of the letter is annexed as Exhibit 8.

19. Respondent did not respond to the Commission's letter of June 14,2023.

20. By letter dated July 13, 2023, which was personally delivered to the Fort Covington Town Court and accepted by the court clerk, the Commission notified Respondent that his testimony concerning the stop-salary complaint was required on August 16, 2023, at 10:30 AM at the Commission's Albany office. The letter noted that the Commission had not received a response from Respondent and enclosed a copy of the complaint, as well as copies of the letters from the Commission dated May 3, 2023, and June 14, 2023. The letter of July 13, 2023, requested that Respondent confirm his appearance by August 7, 2023. A copy of the letter is annexed as <u>Exhibit 9</u>.

21. Respondent neither confirmed his appearance for testimony nor provided any documents to the Commission.

22. On or about August 15, 2023, a member of the Commission's staff telephoned Respondent at his place of employment. Respondent confirmed having received the Commission's letter requiring his appearance the following day for testimony. Respondent stated that he was going to be out of town and could not appear to testify as scheduled, but offered to appear for testimony on his day off the following week, on August 21, 2023.

23. The Commission sent Respondent a letter dated August 15, 2023, to his home address, adjourning his appearance for testimony to August 21, 2023, as he had requested and agreed, and providing directions to the Commission's Albany office. A copy of the letter is annexed as <u>Exhibit 10</u>.

24. Respondent failed to appear at the Commission's Albany office on August 21, 2023, and failed to communicate with the Commission in any manner. A transcript was prepared on August 21, 2023, noting Respondent's failure to appear. On August 23, 2023, a copy of the transcript along with its exhibits and a cover letter were mailed to the Respondent's home address. Respondent personally received and signed for those documents on August 28, 2023. A copy of the transcript along with its exhibits, cover letter and proof of delivery are annexed as <u>Exhibit 11</u>.

25. By reason of the foregoing, Respondent should be disciplined for cause, pursuant to Article VI, Section 22, subdivision (a), of the Constitution and Section 44, subdivision 1, of the Judiciary Law, in that Respondent failed to uphold the integrity and independence of the judiciary by failing to maintain high standards of conduct so that the integrity and independence of the judiciary would be preserved, in violations of Section 100.1 of the Rules; and failed to avoid impropriety and the appearance of impropriety, in that Respondent failed to respect and comply with the law and failed to act in a manner that promotes public confidence in the integrity and impartiality of the judiciary, in violation of Section 100.2(A) of the Rules.

WHEREFORE, by reason of the foregoing, the Commission should take whatever further action it deems appropriate in accordance with its powers under the Constitution and the Judiciary Law of the State of New York.

#### PRELIMINARY STATEMENT

This Memorandum is respectfully submitted by Counsel to the Commission on Judicial Conduct ("Commission") in support of Counsel's Motion for Summary Determination that the Honorable David W. Wilbanks ("Respondent"), a Justice of the Fort Covington Town Court, Franklin County, has committed judicial misconduct.<sup>1</sup> Respondent was served with a Formal Written Complaint ("Complaint") on November 11, 2023. He has not filed or served an Answer. Pursuant to Sections 7000.6(b) and (c) of the Commission's Operating Procedures and Rules, Respondent's failure to serve an Answer is deemed an admission of all the factual allegations set forth in the Complaint and summary determination on the issue of misconduct has been established as a matter of law.

#### PROCEDURAL HISTORY

#### A. The Formal Written Complaint

Pursuant to Judiciary Law §44(4), the Commission authorized a Formal Written Complaint ("Complaint"), dated October 26, 2023, containing two charges, alleging that Respondent: (1) failed to report or remit court funds to the Office of State Comptroller in a timely manner; and (2) failed to cooperate with the Commission's investigation of the complaint that he failed to timely report and

remit court funds to the Comptroller, in that he: (A) failed to respond to two letters from the Commission requesting his response to the complaint that he did not report and remit to the Comptroller; (B) failed to produce court records and other related documents requested by the Commission; and (C) failed to appear for scheduled testimony before the Commission, as was required.

On November 11, 2023, Respondent was personally served with a Notice of Formal Written Complaint and the Complaint (Affirmation of Cathleen S. Cenci ["Cenci Aff."] ¶ 4).

#### B. Respondent's Failure to Answer

Respondent received the Complaint on November 11, 2023 (Cenci Aff. ¶ 4). Pursuant to Section 7000.6(b) of the Commission's Operating Procedures and Rules, Respondent's verified Answer was due within 20 days of service of the Complaint, *i.e.*, on or about December 1, 2023. Respondent has not served an Answer to the Complaint to date (Cenci Aff. ¶ 5).

#### C. <u>The Facts</u>

Pursuant to Section 7000.6(b) of the Commission's Operating Procedures and Rules, which provides that "[f]ailure to answer the formal written complaint shall be deemed an admission of its allegations," the following facts are deemed admitted.

#### As to Charge I:

On or about February 14, 2023, the Comptroller issued to Respondent a written notice that his December 2022 monthly report had not been filed by the 10<sup>th</sup> day of the following month as required and still was not on file with the Comptroller (Complaint ¶ 6, Ex. 1). On or about March 22, 2023, the Comptroller issued to Respondent a second written notice that his December 2022 monthly report had not been filed, and simultaneously notified him that he had failed to file his January 2023 monthly report by the 10<sup>th</sup> day of the following month as required (Complaint ¶ 7, Ex 2). Respondent failed to file his February 2023 monthly report by the 10<sup>th</sup> day of the following month as required on or about mid-April 2023 (Complaint ¶ 8).

On April 20, 2023, the Comptroller left a phone message for Respondent regarding his still-unfiled reports for December 2022, January 2023, and February 2023, as a courtesy before mailing him a notice that his salary would be stopped in connection with those delinquencies (Complaint ¶ 9, Ex 3). That same day, the Comptroller also sent an email to Respondent, again noting the delinquent December 2022 and January 2023 monthly reports and notifying him of his failure to file his February 2023 monthly report in a timely manner. The email further advised Respondent of the prior written notices, as well as the phone message left for him that same day, concerning his delinquent reports (Complaint ¶ 10, Ex 4).

On or about April 18, 2023, the Comptroller notified the Fort Covington Town Supervisor to stop Respondent's judicial salary in connection with his failure to file his monthly reports for December 2022, January 2023 and February 2023. Thereafter, Respondent failed to timely file his reports for March, April and May 2023 (Complaint ¶ 11, Ex 5). Respondent failed to file his monthly reports with the Comptroller for the months of December 2022 through May 2023 until on or about July 6, 2023. Thereafter, Respondent's judicial salary was resumed (Complaint ¶ 12, Ex 6).

#### As to Charge II

By letter dated May 3, 2023, the Commission notified Respondent that it was investigating a complaint from the Comptroller alleging that he had failed to file reports or remit funds to the Comptroller in the time required by law for the months of December 2022, January 2023, and February 2023, which resulted in his judicial salary being stopped on or about April 18, 2023. The letter requested that Respondent provide a written response to the allegations and to produce court records and other related documents by May 31, 2023. The letter was sent to Respondent by regular mail and via email to his court system account:

@nycourts.gov (Complaint ¶ 16, Ex 7). Respondent failed to respond to the Commission's letter of May 3, 2023, and failed to produce any documents requested therein (Complaint ¶ 17).

By letter dated June 14, 2023, the Commission sent Respondent a copy of its letter dated May 3, 2023, and requested his response by June 28, 2023. The letter informed Respondent that his "<u>failure to respond may be found by the Commission</u> to be failure to cooperate with the investigation" (emphasis in original) (Complaint ¶ 18, Ex 8). Respondent did not respond to the Commission's letter of June 14, 2023 (Complaint ¶ 19).

By letter dated July 13, 2023, which was personally delivered to the Fort Covington Town Court and received by the court clerk, the Commission notified Respondent that his testimony concerning the stop-salary complaint was required on August 16, 2023, at 10:30 AM at the Commission's Albany office. The letter noted that the Commission had not received a response from Respondent and enclosed a copy of the complaint, as well as copies of the letters from the Commission dated May 3, 2023, and June 14, 2023. The letter of July 13, 2023, requested that Respondent confirm his appearance by August 7, 2023 (Complaint ¶ 20, Ex 9). Respondent neither confirmed his appearance for testimony nor provided any documents to the Commission (Complaint ¶ 21).

On or about August 15, 2023, a member of the Commission's staff telephoned Respondent at his place of employment. Respondent confirmed having received the Commission's letter requiring his appearance the following day for testimony. Respondent stated that he was going to be out of town and could not

appear to testify as scheduled, but offered to appear for testimony on his day off the following week, on August 21, 2023 (Complaint  $\P$  22).

The Commission sent Respondent a letter dated August 15, 2023, to his home address, adjourning his appearance for testimony to August 21, 2023, as he had requested and agreed, and providing directions to the Commission's Albany office (Complaint ¶ 23, Ex 10). Respondent failed to appear at the Commission's Albany office on August 21, 2023, and failed to communicate with the Commission in any manner. A transcript was prepared on August 21, 2023, noting Respondent's failure to appear. On August 23, 2023, a copy of the transcript along with its exhibits and a cover letter were mailed to the Respondent's home address. Respondent personally received and signed for those documents on August 28, 2023 (Complaint ¶ 24, Ex 11).

#### <u>ARGUMENT</u>

#### POINT I

#### **RESPONDENT HAS ADMITTED THE FACTUAL ALLEGATIONS IN THE FORMAL WRITTEN COMPLAINT.**

Section 7000.6(b) of the Commission's Operating Rules and Procedures requires a judge who is served with a Complaint to serve a verified Answer within 20 days of receipt of the Complaint, and provides that "[f]ailure to answer the formal written complaint shall be deemed and admission of its allegations." Section 7000.6(c) of the Operating Procedures and Rules states that "[e]ither party may move before the commission for a summary determination . . . if the pleadings . . . show that there is no genuine issue as to any material fact and that the moving party is entitled to such decision as a matter of law."

In *Matter of Petrie*, 54 NY2d 807 (1981), the Court of Appeals held that, reading those two provisions together, the Commission may avail itself of summary proceedings if a judge "fail[s] to answer the complaint or raise any question of fact." *Id.* at 808. *See also Matter of Backal*, 87 NY2d 1, 7 (1995) (a judge's failure to respond to a Complaint is deemed an admission of the allegations in the Complaint).

Here, Respondent failed entirely to respond to the Complaint, which serves as an admission of all the allegations and leaves no disputed issues of material fact that would warrant a hearing. Accordingly, this matter is appropriate for summary determination under Section 7000.6(c) of the Operating Procedures and Rules. *Backal*, 87 NY2d at 7; *Petrie*, 54 NY2d at 808.

#### **POINT II**

#### RESPONDENT'S MISCONDUCT IS ESTABLISHED, AND SUMMARY DETERMINATION IS APPROPRIATE AS TO BOTH CHARGES IN THE COMPLAINT.

#### A. <u>Respondent's Failure To Report Or Remit Court Funds In A Timely</u> <u>Manner Constitutes Judicial Misconduct.</u>

Section 2021 of the Uniform Justice Court Act and Section 27 of the Town

Law provide that every town and village justice must file a monthly report with the

State Comptroller. Both the report and the remittance are due by the 10<sup>th</sup> day of the month following the month in which the funds were collected. Section 1803(8), Article 45, Title IX, of the Vehicle and Traffic Law similarly provides that all fines, penalties, and forfeitures collected be credited to the proper governmental unit and accounted for to the Comptroller.

It is well-established that the failure to report and remit court monies to the appropriate authorities constitutes misconduct. *Matter of Persons*, 2024 Ann Rep of NY Comm on Jud Conduct at \_\_\_\_2; *Matter of Ridgeway*, 2010 Ann Rep of NY Commn on Jud Conduct at 205, 209; *Matter of Carver*, 2010 Ann Rep of NY Commn on Jud Conduct at 119, 123; *Matter of Minogue*, 2009 Ann Rep of NY Commn on Jud Conduct at 138, 145.

Here, Respondent engaged in misconduct by failing to comply with the requirements of reporting and remitting funds. Respondent failed to report or remit funds in a timely manner for the months of December 2022 through May 2023, as required by law. Indeed, he did not file those reports until on or about July 6, 2023. Respondent's delinquency resulted in his judicial salary being stopped on April 18, 2023, which constitutes further proof his misconduct.

#### B. <u>Respondent's Refusal To Cooperate With The Commission's</u> <u>Investigation Constitutes Misconduct.</u>

Respondent committed misconduct when he: (1) failed to respond to two Commission letters requesting his response to questions concerning a complaint about his failure to report and remit to the Comptroller; (2) failed to produce court records and other related documents requested by the Commission; and (3) failed to appear for testimony concerning the complaint.

Section 44(3) of the Judiciary Law, and Sections 7000.3(c) and (e) of the Commission's Operating Procedures and Rules, authorize the Commission to request a written response from a judge who is the subject of a complaint, and to require a judge's testimony during the investigation. *Matter of Persons*, 2024 Ann Rep at \_\_\_; *Matter of McAndrews*, 2014 Ann Rep of NY Commn on Jud Conduct at 157, 162; *Matter of McCall*, 2004 Ann Rep of NY Commn on Jud Conduct at 135, 137.

As the Court of Appeals held in *Matter of O'Connor*, 32 NY3d 121, 129 (2018), "those who don the robe and assume the role of arbiter of what is fair and just must do so with an acute appreciation both of their judicial obligations and of the Commission's constitutional and statutory duties to investigate allegations of misconduct" in order for "the public trust in the judiciary is to be maintained." (citing NY Const, art VI, § 22; Judiciary Law, article 2-A). "In short," the Court

concluded, "willingness to cooperate with the Commission's investigations and proceedings is not only required – it is essential." *Id.* 

Consistent with that pronouncement, the Commission has long held that a judge's failure to cooperate during an investigation of alleged misconduct is, in itself, misconduct that "show[s] contumacious disregard for the responsibilities of ... judicial office" in violation of Rules 100.1 and 100.2(A) (requiring a judge to maintain high standards of conduct and to avoid impropriety and the appearance of impropriety). *Matter of Carney*, 1997 Ann Rep of NY Commn on Jud Conduct at 78, 79; *see also Matter of Gregory*, 2000 Ann Rep of NY Commn on Jud Conduct at 109, 111; *Matter of Coble*, 1999 Ann Rep of NY Commn on Jud Conduct at 87, 88; *Matter of Tiffany*, 1995 Ann Rep of NY Commn on Jud Conduct at 140, 142.

In *Matter of McAndrews*, the Commission investigated a judge for failing to timely file a required annual financial disclosure statement with the Ethics Commission for the Unified Court System, and during the course of the investigation, the judge failed to respond to three letters sent by Commission Counsel posing questions pertaining to the allegation against him and declined to respond to two written requests that he confirm his appearance for investigative testimony. *McAndrews*, 2014 Ann Rep at 159-60. The Commission determined that the judge's failure to respond to those letters and written requests constituted misconduct in its own right, violating Rules 100.1 and 100.2(A), notwithstanding that the judge ultimately answered the Formal Written Complaint and appeared for investigative testimony. Specifically, the Commission held, such failure to respond showed "a lack of respect for the process, created by Constitution and statute" and "demonstrate[ed] an unacceptable disregard for the administrative and ethical responsibilities of his judicial office." *Id.*, at 162-63.

Here, as in *McAndrews*, Respondent failed to respond to multiple letters from the Commission posing questions pertaining to the allegations against him and failed to respond to two written requests that he confirm his appearance for investigative testimony. To make matters worse, Respondent also failed to produce documents requested by the Commission during its investigation, failed to appear for his investigative testimony, and failed to file or serve an Answer to the Complaint. The totality of that conduct constitutes a clear violation of the Rules.

#### CONCLUSION

For the foregoing reasons, Commission Counsel respectfully requests that the Commission grant this motion for summary determination, find that Respondent has engaged in judicial misconduct, and set a schedule for briefs and oral argument before the Commission on the issue of sanction.
