Greene County Town Court Justice Resigns While Under Investigation for Misconduct

David A. Rikard, a Justice of the Prattsville Town Court, Greene County, resigned from office while under investigation by the New York State Commission on Judicial Conduct.

Judge Rikard refused to cooperate with the Commission during its investigation of three complaints against him. He refused to provide documents the Commission requested, and he refused to appear for testimony when summoned by the Commission.

Judge Rikard resigned from office on January 6, 2023. The Commission's inquiry nevertheless continued, and on January 26, 2023, he was served with formal disciplinary charges for the failure to cooperate. He admitted the facts, agreed to never seek or accept judicial office in the future, and waived the statutory provision of confidentiality applicable to Commission proceedings, to the limited

¹ Under the Judiciary Law, the Commission has 120 days from a judge's resignation to issue a determination that the judge should be removed. Under the Constitution, a removed judge is ineligible to hold judicial office again.

extent that the stipulation and the Commission's order accepting it would be public. The Commission accepted a stipulation to that effect signed by the judge, his attorney and the Commission's Administrator.²

Judge Rikard, who is an attorney, had served as a Justice of the Prattsville Town Court since 2014. His current term would have expired on December 31, 2025.

Statement by Commission Administrator

Commission Administrator Robert H. Tembeckjian made the following statement.

"Cooperation is mandatory, not optional, when judges are called to account by the Judicial Conduct Commission. Stonewalling or otherwise refusing to participate undermines public confidence in the integrity of the judiciary and can result in removal from office."

Statistics Relating to Prior Commission Decisions

The Commission has accepted 126 such stipulations since the procedure was instituted in 2003.

Since 1978, the Commission has issued 281 determinations of admonition against judges in New York State, 347 determinations of censure and 179 determinations of removal.

The Court of Appeals has reviewed 101 Commission determinations. The Court accepted the Commission's sanctions in 85 cases (76 of which were removals, six were censures and three were admonitions). Of the remaining 16 cases, two sanctions were increased from censure to removal, and 13 were reduced: nine removal determinations were modified to censure, one removal was modified to admonition, two censures were modified to admonition, and one censure was rejected and the charges dismissed. The Court remitted one matter to the Commission for further proceedings. One request for review is pending.

² The stipulation was signed on March 10, 2023. The Commission issued an order accepting it on April 20, 2023.
