Town Justice in Rockland County Resigns Under Investigation for Not Disclosing a Conflict and for Prohibited Political Activity

Scott B. Ugell, a Justice of the Clarkstown Town Court, Rockland County, resigned while under investigation by the New York State Commission on Judicial Conduct.

In March 2023, the Commission apprised Judge Ugell it was investigating a complaint that he presided over a landlord/tenant case without disclosing that an attorney in the case had personally represented him in an unrelated matter, and for not affording the opposing party an opportunity to be heard.

In April 2023, the Commission advised Judge Ugell it was investigating a second complaint, alleging that he became a candidate for Clarkstown Town Supervisor without resigning from his position as Clarkstown Town Justice.

In May 2023, the Commission advised Judge Ugell it was investigating a third complaint, alleging that he testified falsely in a lawsuit claiming he was ineligible to run for town supervisor.¹

Judge Ugell agreed to resign from office effective June 30, 2023, and never to seek or accept judicial office at any time in the future. The Commission accepted a

stipulation to that effect signed by the judge, his attorney, and the Commission's Administrator.²

Judge Ugell waived the statutory provision of confidentiality applicable to Commission proceedings, to the limited extent that the stipulation and Commission's order accepting it would be public.

Judge Ugell, who is an attorney, had been a Justice of the Clarkstown Town Court since 1991. His current term would have expired on December 31, 2025.

Statement by Commission Administrator

Commission Administrator Robert H. Tembeckjian made the following statement.

"Public confidence in the integrity and impartiality of the courts requires a judge to step aside in cases where there is a conflict, or disclose the conflict so the parties may request a new judge. It also requires separating politics from the bench, meaning a judge must resign upon becoming a candidate for non-judicial office. And it should go without saying that, when called as a witness, a judge must always testify truthfully."

Statistics Relating to Prior Commission Decisions

The Commission has accepted 127 such permanent resignation stipulations since the procedure was instituted in 2003.

Since 1978, the Commission has also issued 281 determinations of admonition against judges in New York State, 348 determinations of censure and 179 determinations of removal.

The Court of Appeals has reviewed 101 Commission determinations. The Court accepted the Commission's sanctions in 85 cases (76 of which were removals, six were censures and three were admonitions). Of the remaining 16 cases, two sanctions were increased from censure to removal, and 13 were reduced: nine removal determinations were modified to censure, one removal was modified to admonition, two censures were modified to admonition, and one censure was

rejected and the charges dismissed. The Court remitted one matter to the Commission for further proceedings. One request for review is pending.
